#### 1. INTRODUCTION

Article 104 of the Constitution of the Republic of Seychelles provides the National Assembly with the powers that allow our institution to set up committees that serve in the efficient discharge of members responsibilities. It is one of the mechanisms at the disposal of the National Assembly in its quest for good governance, transparency and accountability of the Executive. The International Affairs Committee (IAC) of the 6<sup>th</sup> National Assembly was established following a motion approved by the National Assembly on 4<sup>th</sup> October 2016.

Article 104 of the Constitution of the Republic of Seychelles, the Rules and Procedures for Committees and Standing Orders 2009 provide the statutory and procedural authority for the establishment and functioning of the IAC.

The Committee Members have for the past year worked to maintain the existing bilateral relations, have participated in international meetings and seminars, and have represented the National Assembly at local functions organized by foreign partners or locally based Diplomatic Missions.

The IAC is mandated as per its Terms of Reference laid out in Annex 1.

#### 4. MEETING WITH DIGNITARIES

- The Chair met with the Ms. Judith Galambos, Deputy Head of Mission from the Embassy of the Republic of Hungary based in Nairobi, Kenya on 5<sup>th</sup> March 2018.
- The British High Commissioner H.E. Ms. Caron Rohsler (accompanied by Mr. Matthew Harper, Political Counsellor at the High Commission) met with the Committee on 17th April 2018.
- The Committee met with the EU Ambassador H.E. Mrs Marjaana Sall on 26th April 2018 during her working visit to Seychelles. She was accompanied by the Project Coordinator at the Embassy, Mr. Rajesh Parbooteah. The Deputy Speaker Hon. Ahmed Afif was also in attendance to represent the Speaker.
- Mrs Monica Michel (MP) and Chairperson of the Seychelles-France Friendship Association from France, met with the Committee on Friday 27<sup>th</sup> April 2018 whilst in Seychelles during a private visit.
- The IAC Members formed part of the National Assembly team comprising of the Speaker, Deputy Speaker, LOTO, LGB, Clerk and Deputy Clerk to meet with the EU Delegation on Wednesday 7th November 2018 held at the National House Conference Room.
- The Chairperson of IAC was in attendance for the courtesy call on the Speaker by the new Chinese Ambassador H.E. Mrs Guo Wei on 15<sup>th</sup> October 2018.

#### 5. OTHER MEETINGS

- The IAC and the FPAC had a joint meeting with Vice President Vincent Meriton with regard to the Assumption Island issues on 9th February 2018 at State House and a visit was also effected on the island involving members from both Committees.
- The Committee had a joint meeting with the Department of Foreign Affairs and the Department of Trade for the purpose being briefed on the Post-Cotonou Negotiations on Wednesday 23<sup>rd</sup> May 2018. Present were Ambassador Barry Faure who was accompanied by Ms. Amenda Padayachy (DG for International Relations and Regional Integration) and Mr. Marco Larson (Liaison Officer from the Division) and Ms. Cilia Mangroo Principal Secretary for Trade.
- A team of five officials from the Trade Division Department of Trade in the Ministry of Finance, Trade, Investment and Economic Planning comprising of PS Cilia Mangroo, Mr. Charles Morin - Chief Negotiator, Mr Ricky Barbe - Senior Trade Officer, Mr Rennick Charlette - Trade Officer and Ms Veronique Brutus Trade Officer spent an afternoon for a presentation on the International Trades Agreement and Negotiation to the Committee Members on Friday 8th June 2018. Members had a chance to ask questions and clarifications obtained on their various queries.
- The Department of Trade initiated a meeting with the Committee on 12<sup>th</sup> July 2018 and Dr. Gustav Brink (a Consultant from South Africa) mandated to work on a project to implement a national legal framework for trade remedies/trade defence measures, which should allow Seychelles to establish a mechanism for antidumping, safeguards and countervailing measures. - Members of the Committee met with officials from the Trade Department on 12<sup>th</sup> December 2018 following request made by the latter for a briefing on the ongoing BREXIT negotiations.

- Hon. Waven William formed part of the delegation that also comprised of Hon. Jany Letourdi and Mrs Tania Isaac – the Deputy Clerk to the 138th IPU General Assembly held in Geneva, Switzerland from 23rd to 30th March.
- 50<sup>th</sup> Session of the ACP Parliamentary Assembly and 35<sup>th</sup> Session of the ACP-EU Joint Parliamentary Assembly held from 13<sup>th</sup> to 20<sup>th</sup> June in Brussels, Belgium, attended by Hon. Clifford Andre and Hon Waven William.
- Hon. Noline Sophola formed part of a delegation to participate in the Regional Symposium on Heightening the Protection for Key Populations in the SADC Region that was held in Johannesburg, South Africa from 27th to 30 August.

dialogue intercultural" that took place in Antananarivo, Madagascar from  $8^{\rm th}$  to  $9^{\rm th}$  May.

 Hon. Ferrari proceeded to Washington DC, USA from 13<sup>th</sup> to 20<sup>th</sup> July 2018 for discussions on the US Foreign Policy.

#### 8. FRIENDSHIP ASSOCIATION GROUPS

- 7.1 Friendship Association Groups have been established between Seychelles and the following countries: France, Russia, China, India, Cuba, Ghana and Algeria.
- 7.2 The Seychelles-Russia Friendship Association met with the Russian Ambassador H.E. Mr Vladimir Belous on 21st August. Discussions were around ways to strengthen the bilateral relations between Seychelles and Russia; further assistance in the field of education and trade and exchanges between the two parliaments.

#### 9. RECOMMENDATION

The IAC, at various committee meetings and discussions, has recommended that a special budget line be established for the Committee's activities for the year 2020 and that this be provided for each subsequent financial year. For 2020, the IAC will make recommendations for this purpose to the Clerk of the National Assembly.

That the IAC be officially invited to take part in the negotiations of the new EU/Seychelles Fisheries Partnership Agreement that will be debated in 2019 for the new agreement that is to come into force in 2020. The IAC has repeatedly insisted on this point both with the EU visiting delegations and the Seychelles Ministry of Foreign Affairs, but with no success so far. The IAC wishes to make it clear that it will not recommend the ratification of any Fisheries Agreement if it has not been part of the negotiations.

#### 10. CONCLUSION

The IAC believes that, in the absence of a Minister for Foreign Affairs, it has played a meaningful role in assisting the Government of Seychelles in its diplomatic obligations. The IAC, upon request from

the Speaker, has attended discussions with all foreign delegations that have visited the National Assembly.

For the months ahead, the IAC has committed itself to renew ties with the "Association Parlementaire de la Francophonie", which for too long have been dormant. The IAC is assisting the National Assembly in clearing its arrears with the APF and is hoping to get back to full member status as from the beginning of 2020 when it is hoping to be able to host an event of the organization in Seychelles.

# NATIONAL ASSEMBLY OF SEYCHELLES INTERNATIONAL AFFAIRS COMMITTEE (IAC) TERMS OF REFERENCE

- (i) To work closely with the Ministry of Foreign Affairs, other governmental and non-governmental organizations on international affairs, peace, security and defence and contribute thereon as and when necessary.
- (ii) To maintain existing and establish new ties with foreign parliamentary organizations of interest.
- (iii) To perform any other tasks as may be assigned by the National Assembly.
