**Licences (Liquor and Outdoor Entertainment)
(Amendment) Regulations, 2019**

In exercise of the powers conferred by section 28 of the Licences Act, the Minister responsible for Finance makes the following regulations —

1. These regulations may be cited as the Licences (Liquor and Outdoor Entertainment) (Amendment) Regulations, 2019 and shall come into operation on 1st day of June, 2019.

Citation

2. The Licences (Liquor and Outdoor Entertainment) Regulations, 1988 are amended as follows —

(a) by repealing paragraph (i) of subregulation (3) of regulation 14 and substituting therefor the following paragraph —

“(i) There shall not be any sale of liquor by holder of a licence set out in Schedule D outside the hour of sale on the days specified below —

Monday	-	1.30 p.m. to 9.00 p.m.
Tuesday	-	1.30 p.m. to 9.00 p.m.
Wednesday	-	1.30 p.m. to 9.00 p.m.
Thursday	-	1.30 p.m. to 9.00 p.m.
Friday	-	1.30 p.m. to 11.00 p.m.
Saturday	-	8.30 a.m. to 11.00 p.m.
Sunday	-	8.30 a.m. to 9.00 p.m.”;

- (b) by inserting after subregulation (3), the following subregulation—

“(3A.) There shall not be any sale of liquor by holder of a licence set out in Schedule E outside the hour of sale on the days specified below —

Monday	-	1.30 p.m. to 9.00 p.m.
Tuesday	-	1.30 p.m. to 9.00 p.m.
Wednesday	-	1.30 p.m. to 9.00 p.m.
Thursday	-	1.30 p.m. to 9.00 p.m.
Friday	-	1.30 p.m. to 1.00 a.m.
		on Saturday
Saturday	-	8.30 a.m. to 1.00 a.m.
		on Sunday
Sunday	-	8.30 a.m. to 1.00 a.m.
		On Monday”;
