PUBLIC SERVICE SPECIAL PENSION ACT, 2017

(Act 24 of 2017)

Public Service Special Pension (Life Certificate) Regulations, 2019

In exercise of the powers conferred by section 10(1) of the Public Service Special Pension Act, 2017, the President acting as the Minister for Public Administration hereby makes the following Regulations—

1. These Regulations may be cited as the Public Service Special Pension (Life Certificate) Regulations, 2019.

Citation

2. A person in receipt of a special pension shall produce every six months, a Life Certificate in the form set out in Part 1 of the Schedule, to the Department of Public Administration.

Life Certificate for pensioner

3. Where a person in receipt of a special pension is subject to interdiction, the Guardian of the person in receipt of a special pension shall produce every six months, a Life Certificate in the form set out in Part 2 of the Schedule, to the Department of Public Administration.

Life Certificate for interdicted

4. Where a person in receipt of a special pension is unable to sign or make his or her mark due to physical incapacity, the person in receipt of a special pension or a close relative of the person shall produce every six months, a Life Certificate in the form set out in Part 3 of the Schedule, to the Department of Public Administration.

Life Certificate for physically incapacitated pensioner

5. Where a person in receipt of a special pension for reasons of serious physical incapacity cannot appear before any of the person specified in Schedule 3 to the Act, the person

in receipt of a special pension or a close relative or the home carer of the person in receipt of a special pension shall produce every six months, a Life Certificate in the form set out in Part 4 of the Schedule, to the Department of Public Administration.

Repeal of S.I. 45 of 2018 6. The Public Service Special Pension (Life Certificate) Regulations, 2018 is hereby repealed.
