## THE TRUTH, RECONCILIATION AND NATIONAL UNITY COMMISSION ACT, 2018

(Act 9 of 2018)

The Truth, Reconciliation and National Unity Commission (Salary and Allowances of Chairperson, Vice-Chairperson and Commissioners) Regulations, 2019

In exercise of the powers conferred by section 15 (4) of the Truth, Reconciliation and National Unity Commission Act, 2018 the President being the Minister for Public Administration makes the following regulations—

1. These regulations may be cited as the Truth, Reconciliation and National Unity Commission (Salary and Allowances of Chairperson, Vice-Chairperson and Commissioners) Regulations, 2019.

Citation

2.(1) The monthly salary of the Chairperson shall be the sum specified at Step 2 of Salary Band 17 of the Public Service Salary Table, under the Public Service Salary Act, 2013 (Act 25 of 2013).

Salary of Chairperson

- (2) Where the Chairperson is a non-Seychellois, he or she shall be eligible for—
  - (a) (i) air travel to and from Seychelles by the most economical route at the beginning and the end of the term of service for himself or herself, his or her spouse and up to four children who are below the age of 18 years;
    - (ii) one return air fare from Seychelles to his or her country of residence by the

most economical route, for himself or herself, his or her spouse and up to four children who are below the age of 18 years, during the term of service;

- (b) a supplementation allowance of SCR28,000 per month;
- (c) free accommodation;
- (d) an education allowance of SCR5,000 per month per child for up to 4 children who are aged 3 to 18 years and enrolled in a registered educational institution in Seychelles;
- (e) medical insurance;
- (f) a chauffeur driven car;
- (g) access to telephone, internet and data facilities in accordance with a signed service agreement.

Salary of Vice-Chairperson

- **3.**(1) The salary of the Vice-Chairperson shall be eighty-six percent (86%) of the salary of the Chairperson.
- (2) Where the Vice-Chairperson is a non-resident, he or she shall be eligible for—
  - (a) air travel to and from his or her country of residence for attending the meetings of the Commission;
  - (b) accommodation and local travel costs during his or her visit to Seychelles for attending the meetings of the Commission;
  - (c) a reduced per diem during his or her visits to

Seychelles for attending the meetings of the Commission;

- (d) medical insurance while in Seychelles.
- **4.**(1) The monthly salary of the Commissioners shall be seventy-five (75%) of the salary of the Chairperson.

Salary of Commission

- (2) Where a Commissioner is a non-resident, he or she shall be eligible for
  - (a) air travel to and from his or her country of residence for attending the meetings of the Commission;
  - (b) accommodation and local travel costs during his or her visit to Seychelles for attending the meetings of the Commission;
  - (c) a reduced *per diem* during his or her visits to Seychelles for attending the meetings of the Commission;
  - (d) medical insurance while in Seychelles.
- 5. The terms and conditions specified in the Public Service Orders shall be applicable to the Chairperson and Commissioners, subject to these regulations.
