## IMMIGRATION DECREE

(Cap 93)

## **Immigration (Amendment) Regulations, 2022**

In exercise of the powers conferred by 29(c) of the Immigration Decree, the Minister responsible for internal affairs, makes the following regulations —

#### **Citation and commencement**

**1.**(1) These Regulations may be cited as the Immigration (Amendment) Regulations, 2022.

(2) Paragraphs 5(c) and 5(d) shall be deemed to have come into operation on the 01<sup>st</sup> January, 2022.

## Amendment of Second Schedule Fees

**2.** The Immigration Regulations are amended in the Second Schedule by deleting item 5 and substituting therefor the following —

"5. Gainful Occupation Permit —

"(a)	for workers who have worked in	SCR500
	Seychelles for a period of one	
	month	

- (b) for workers who have worked in SCR6000 Seychelles for a period of twelve months
- (c) for agricultural workers who have worked in Seychelles for —
  - (i) a period of one month or part thereof SCR125

**Note:** For the purposes of paragraph 5(c) "agricultural workers" include a person gainfully occupied or applying for a gainful occupation permit to work in the areas of —

- *(i)* agricultural domains as recommended by the Ministry responsible for agriculture;
- *(ii)* cultivation of crops or the rearing of livestock for commercial purposes;
- *(iii)* value addition of crops or the rearing of livestock for commercial purposes;
- *(iv)* horticulture, arboriculture, ornamental production, forestry, husbandry or farm management, but shall not include work in the areas of fisheries or kitchen gardens.

For the purposes of paragraph 5(d) —

"workers who have worked on semi-industrial fishing vessel", means a person gainfully occupied or applying for a gainful occupation permit to work on semi-industrial fishing vessel and;

"semi-industrial fishing vessel" has the same meaning given in the Fisheries (Mahé Plateau Trap and Line Fishery) Regulations, 2021 (S.I. 77 of 2021). [22nd August 2022]
