PRINCIPAL MINISTER JEAN-FRANÇOIS FERRARI

Mon rekonnèt Mr Speaker, lentere nasyonal lo sa size parey bann Manm in fer resorti dan zot lentervansyon e sirtou laspe ledikasyon pour ki nou bann partner - sirtou nou bann peser lokal i konpran byen provizyon sa Lalwa ki konsern zot direktman.

Pour sa Mr Speaker, apre ki sa Lalwa in pase, mon Minister ansanm avek *SFA* nou a kordinen pou nou organiz bann sesyon *awareness* parey serten Manm in demande pou nou bann peser atraver zot lasosyasyon. Toudmenm, mon oule fer resorti ki i annan bokou rankont konsiltasyon ki

nou'n fer avan ki sa *Bill* in vin devan Lasanble.

E mon remersi tou group dimoun enkli bann ki - bann Lasosyasyon Peser ki'n partisip dan sa bann rankont konsiltasyon e aport bann kontribisyon vremen valab. Dapre lentervansyon bann Manm yer, i kler ki tou Manm i siport sa Lalwa, me sa pa oule dir ki i perfe. lenfrastruktir Akwakiltir. Kestyon in osi ganny demande lo kapasite *SFA* pou reglemant sa sekter.

Mr Speaker, provizyon sa nouvo Lalwa kot i konsern lamenzman e devlopman Akwakiltir anba seksyon 47 in adres tou sa konsern. E plan pou amenaz e devlop Akwakiltir anba sa Lalwa, pou ganny revize tou le 5 an pou asire pour ki okenn devlopman dan sa sekter i ganny fer an konformite e kad legal.

Sa Lalwa i reglemant tou sa ki ganny servi dan devlopman Akwakiltir. Depi metod ki sa devlopman i ganny fer, lespes ki i kapab ganny kiltive, latizann ki ganny otorize, lezot litilite ziska kalite manze flit ki nou apele, ziska kalite manze ki ganny servi.

I bon fer resorti Mr Speaker, ki bann konsern ki'n ganny souleve par Onorab Hoareau e lezot i bann size ki'n deza fini ganny adrese dan sa letid lenpak sosyal e lanvironnman ki *SFA* in antreprann pandan 12 mwan depi an 2016.

Sa letid, ti ganny en kantite latansyon par bann eksper dan akwakiltir, lapas e lanvironnman, e sa rezilta in ganny diskite e detaye e in ganny adrese. Sa rapor i lo *sit web* Akwakiltir e bann Manm i kapab pas ladan pou war en pe sa bann diskisyon e konsern avek son bann solisyon ki pe ganny propoze.

Sa provizyon i konsistan avek lezot provizyon anba seksyon 22 kot i en lofans pou enterfer ou andomaz propriyete en lot dimoun dan delo Sesel, menm parey dan bann lensidan kot dimoun i enterfer e andomaz kazye bann peser par egzanp.

Onorab Aglae, in demande yer ki reperkision ki bann *FADs* i annan dan son totalite. Mr Speaker, si nou *ban FADs*, sa pou annan en gran reperkision ekonomik e menm sosyal lo nou pei. Dan lapés ton tropikal pli gran kantite lespes ton ki ganny atrape se *Skipjack*, Ton Reye parey nou dir. Ki reprezant an mwayenn 66poursan totalite sa lapés.

E lo lanpler komersyal napa bokou fason pou lapes *skipjack* apard ki avek lasenn asosye ek *FADs*. Menm metod *pole-and-line* i lapes *Skipjack* ek labwet vivan ki asosye ek *FADs* menm si i bann *FADs* ki *anchored* savedir ki'n anmare dan fon lanmer.

Lapes *skipjack* lo *free schools* ki nou apel bann ban flotan kot sa bann pwason i naz lib san *FAD* e i terribleman difisil teknikman pa pratik e i pa en metod ki pou ekonomikman vyab ou bann bato lapas.

Par kont, si lapas ek lasenn ek *FADs* i ganny byen zere, parey nou'n war pou Ton Zonn stok sa lespes i kapab rekipere, parey komite syantifik *IOTC* in deklare dan son *assessment* lo sa stok an Desanm.

An sa ki konsern proibisyon pou servi avyon e *drones*, en kestyon ki ti ganny leve e lalimyer artifisyel dan lespes anba seksyon 20 ek 22, sa i en lobligasyon *IOTC* ki ti vin an fors an 2016, me par kont Lalwa i fer leksepsyon egzanpsyon pou otoriz bann lapas ki kapab servi lalimyer artifisyel tel ki lapes *Sword Fish* e bann bato lokal artizanal pa ganny restrikte pou servi lalimyer artifisyel.

Par kont *authorised officer* i ganny apwente par Minis anba *Fisheries Act*. Alors, si Minis i revok son apwentman koman en *authorised officer* sa pa pou

afekte son lanplwa. Me i kler ki par ou zofisye ou travayer *SFA* ki annan responsabilite pou ranforsi Lalwa lapes.

Apard bann Lotorite Lalwa parey lapolis e menm Lafors Defans ki zot stati koman bann zofisye otorize i otomatikman anba sa Lalwa, en zofisye *SFA* ou en lot zofisye piblik i ganny donnen sa responsabilite i ganny apwente sa stati *Authorised Officer* anba sa enn Lalwa selman.

Sa pa afekte stati sa travayer koman en anploye *SFA*. Sa i en stati adisyonnèl ki donn li sa pouvwar pou deservi responsabilite pou ranforsi Lalwa Lapes ek Akwakiltir. Si lapwentman en *authorised officer SFA* in ganny terminen anba Lalwa Lapes ek Akwakiltir. sa napa lefe lo son lapwentman koman en zofisye *SFA*.

etrvatman avek lapolis ek Biro *Attorney Zeneral* pou tou ka ki ganny anmenn Ankour.

An sa ki konsern aplikasyon sa Lalwa, Lalwa i aplikab dan delo Sesel dan son totalite e menm dan delo otour bann Zil Elwanye e tou kalite lapes ki ganny pratike san okenn eksepsyon. An sa ki konsern *sports fishing* e konpetisyon lapes, sa i pou ganny adrese dan regilasyon ki pou vin apre ki sa Lalwa in pase.

Me Mr Speaker, i enportan pou mwan fer resorti ki anba sa Lalwa nou bezwen nou pou protez peser artizanal e sa pou sa rezon oubyen kler pou nou ki pratik lapes rekreyonnèl e *subsistence*, pa kapab vin an konpetisyon ek bann peser artizanal.

Definisyon *subsistence fishing* ki en definisyon enternasyonal i kler, ler ou lapes pou *subsistence* i vèdir sa pwason i pou ou prop konsonmasyon, pou konsonmasyon ou fanmir, i pa en lapes komersyal. Okenn lapes ki apre sa pwason i ganny vann i en lapes komersyal, e en lapes komersyal i en lapes ki bezwen en *licence*.

E ler en lapes ki pa komersyal, i napa en *licence*, e sa pwason i ganny vann, sa i en lofans, sa menm lofans i aplikab pou lapes

rekreasyonnel oubyen lwazir. Pou mwan fer li pli kler Mr Speaker, si en dimoun i *freight* en bato pou al lapès, en *hire craft HC* parey nou ti pe diryer, i kler ki bit sa lafwetman oubyen sa alokasyon sa bato i pou lapès lwazir. Alors, sa dimoun pa kapab pran son pwason pou al vann ek en lotel oubyen ek en restoran.

To provide for the domestication of regional and

international instruments, obligations and standards and for related matters. Mersi, Mr Speaker.

MR SPEAKER

16(1)(a) "A vessel, shall not have on board, deploy or maintain any fish aggregating device in Seychelles waters". Ok, sa bout after the word "not" nou'n add "have on board, deploy or maintain any fish aggregating deice in Seychelles waters".

MR SPEAKER

HON JOHN HOAREAU

MR SPEAKER

HON SEBASTIEN PILLAY

MR SPEAKER

Ok. Onorab Hoareau, back to you.

HON JOHN HOAREAU

Can't it be the FAD is or maybe stranded? But it is stranded, or it may become stranded...

HON BERNARD GEORGES

Or is at risk of being stranded.

MR SPEAKER

Something like that yeah. So, lekel ki ou ti a prefere? Donn enn.

HON BERNARD GEORGES

At risk of.

HON BERNARD GEORGES

At risk of being stranded.

MR SPEAKER

Panel ek Manm, okenn lobzeksyon? *Sorry?* Relir? Oule ki i relir, *ok?* Onorab Georges, si ou kapab zis relir antye.

HON BERNARD GEORGES

Sertennman Mr Chair. *So, that 2(a) will read "the FAD is stranded or at risk of being stranded within coastal ecosystems etc., etc"*

MR SPEAKER

I pou permet en dimoun koman i war en *FAD*, i dir mon pa kontan manke i pou al tonm *Aldabra* la, mon anmas li, *ok? So, it has to be* dan en pozisyon kot i klerman annan en gran risk pou li *stranded it's not just* - nou bezwen kalifye *what is...*

HON BERNARD GEORGES

Annefe Mr Chair, avek ou permisyon mon ti'n propoze dan mon premye soz "*imminent risk*". *The risk is obvious.*

MR SPEAKER

Onorab Pillay?

HON SEBASTIEN PILLAY

Mr Chair, mon krwar ler mon pe ekout Minis, konsern ki ou annan se ki sa sityasyon *FAD* i en size ekolojik. Ou annan bann dimoun ki bann *eco warriors*. E mon konpran ki Minis ti pe dir, akoz in fer en lofans anler pou si ou *temper* avek sa.

So, Onorab Georges pe sey fer anmenn nou pou

konpran *imminent risk of being stranded*. E ou ou'n dir *the opinion is subjective*, nou ti pe al dan lenpas. *How can panel...?* Ki *panel* i kapab vi ki zot annan sa konesans lefe prepar sa Lalwa.

MR SPEAKER

Thank you. PS?

HON SEBASTIEN PILLAY

...ganny something for the panel pou kapab re zwenn le de.

MR SPEAKER

Kekfwa *PS* i annan en propozisyon?

PS ROY CLARISSE

Kekfwa zis en lenformasyon adisyonnèl pou Lasanble. Statistik ki *SFA* i annan i montre poudir 90poursan *FADS* ki driv 3000 notik avek lakot pa ganny *stranded or beached*. So, en gran poursantaz *FADS* menm si zot ariv pre avek lakot zot pa zanmen tonm lo lans oubyen pri dan koray. Zot kontiny zot tranzitwar.

Sanmenm sa ki nou en pe nou krentif se the risk ki annan en pe *ambiguity* ladan, ki manner ou definir poudir sa risk i reel - i pou *strand* ?

MR SPEAKER

Wi, Onorab Georges?

HON BERNARD GEORGES

Wi, Mr Chair. La mon pa pou dakor avek. Anfen mon pa kapab *challenge statistik PS*. Me 90poursan 3000 ekek *FAD*. I *still* les plizyer santenn *FAD* ki tonm lo lans. Annefe mwan mon kapab dir aköz mon'n la dan 2 kilomet lans lo *Ile du Sud*, *Farquhar* mon'n retrouv 21 *FAD*. E sa se *visible on the beach*, e statistik i montre nou ki pou sa 21 ki mwan mon'n war i annan ankor 21 par anba ki'n fini ganny kouver avek disab.

So, if we leave "stranded" nou bezwen sa dimoun ki lo zil *Farquhar* e ki war en *FAD* pe vini, i bezwen asize esper li mont lo lans apre pou *retrieve* li pa pou kapab anmas li dan lagon. *And that's it's self defeating*. So, nou bezwen trouv en balans. Mon konpran ki nou pa bezwen les bann *eco warriors* pou al zis anmas *FAD* en pe partou. *That counterproductive, me at the same time* nou bezwen kapab anpes *FAD* tonm lo lans, ou may dan resif avan ki nou al *retrieve* li.

E donk, nou bezwen trouv sa balans, se pou sa rezon ki mon pa an faver ki nou les li *stranded* avan ki nou atak li.

MR SPEAKER

Wi, Minis?

PRINCIPAL MINISTER JEAN-FRANCOIS FERRARI

Mr Speaker, i annan bann mezir ki pli boner nou'n koz lo inovasyon teknozik. E i annan bann mezir e bann mezir ki pe ganny vin kontrayan anba bann eleman *IOTC*, pou ki tou bann *FADS* ti ganny idantifye elektronikman. Ki zot moman i ganny *tracked on a regular basis*, pou nou kapab entervenir avek bann lazans ki nou pe fer dan bann program parey *FAD Watch* pou war li ler i pe - *it's imminently ...* en zil e son resif.

Nou bezwen kapab determinen kisisa *imminent*. Sitan ki nou pa kapab fer sa, nou bezwen zis rod en fason pou nou anpes zot elektronikman pou zot *beached*. Me zis donn en posibilite nenport dimoun entervenir, i kapab annan... *well*, i pou kont sa ki nou'n fer pli boner lo bann *interventions* lo bann *fishing...*

MR SPEAKER

Yes, Onorab Georges.

HON BERNARD GEORGES

Mersi, Mr Chair. *Sorry*, mon pe ensiste lo la. Me lo Providence lannen pase, sak *FAD* ki nou'n anmase in anmas plizyer ti annan en *transponder* lo la. Savedir ki sa bann dimoun ki sipoze elektronikman pe sirvey

zot *FAD* pa pe fer li. *Every single one of them* ti annan en *transponder* lo la, avek en mark idantifikasyon - e nou kapab konnen egzaktman lo ki bato i sorti.

So, that doesn't work. Zot abandonnen, zot les li al tonm lo Providence. Lekel ki pou war li Providence fodre en syantis fou ki al laba ki war li, e ki war li lo en zil. Mon pa kapab aksepte - *anyway that putting it in high.* Me mon pa kapab aksepte ki nou pou les en posibilite kot nou bezwen esper bato - en *FAD* ariv lo en lans oubyen may dan en resif avan ki nou kapab dil avek li.

Nou bezwen annan sa posibilite anpes li *strand*. Anpes li *becoming stranded*, san ki - e la mon toutafe dakor avek Lotorite Lapes - san ki nou enterfer avek bann *FAD* ki pe fer zot travay ki pe anvi get pwason pou sa sekter. Me nou bezwen trouv en balans.

MR SPEAKER

Thank you. Onorab Pillay?

HON SEBASTIEN PILLAY

Mersi, Mr Chairman. Mr Chairman, mon krwar Lasanble an antye, i annan en lopinyon ase serye lo sa size *FAD*.

Me selman nou'n pas bann *previous sections* dan Lalwa, ki fer ki si nou le entrodwir en eleman

sibzektivite dan laplikasyon. Akoz la nou pe *deal* avek en lapes ki *licence*. I annan bann regilasyon ki sa bann dimoun in swiv. I annan bann prosedir, bann otorizasyon ki zot in gannyen, ki kapab konpromet Lotorite ler in fer sa. Nou bezwen mazin tou le de kote. *At the same time*, largiman ki'n ganny avanse ki 90poursan *FAD*.

Me si Onorab Georges pe dir mwan in vwar 21 *FAD*, zis Farquhar, so 90poursan 3000 i 270. *You're looking at 30 FAD*, dan sa 30 *FAD*, 21 ariv Farquhar.

Then the statistics, mon pa le kestyonn statistik - me statistik nou pe gannyen petet i pa, i pa koresponn avek keksoz ki nou pe war. So mon krwar nou pour bezwen rod en *middle of the way solution*, pour Lasanble e pour *panel*. *Otherwise* nou pour pe konpromet travay ki nou'n komanse depi boner.

Vi ki nou annan *buy-in* preski tou dimoun al anndan lo sa Lalwa, *we have to find a way forward*. So ou bezwen kapab annan en propozisyon. Si nou pa dakor ek *imminent risk* akoz i annan en eleman sibzektivite e zistans, nou pa pe kapab definir zistans kot en *FAD* i sipoze poz en risk.

At the same time Onorab Georges i annan rezon. Si en *FAD* in fini antre lo resif, in

anpandan lo resif. Bann ki'n vizit bann zil kot i annan sa bann resif, ou vwar ki mannyer i difisil menm pour retir sa bann *FAD*, *once* in antre lo sa bann resif. Mr Speaker akoz i maye la.

I annan lasenn, i annan en kantite debri ki i kree, e menm torti i pri ladan. Ou war bann – i annan torti ki ou'n deza war akoz ou'n vizit zil mon'n war. So nou bezwen kapab rod en solisyon.

So mon pa konnen si zot annan en propozisyon *panel* ki kapab met devan nou ? Vi ki sa i en keksoz ki konsern bann *commitment* ki *panel* i bezwen fer, *as* en Lotorite an relasyon ek sa lapas. Sirtou lapas *purse seiner*.

MR SPEAKER

Yeah, ok. Well, panel Lasanble pe zis rod en mannyer *strengthen* sa soz, pour ganny en pe plis lasirans. Onorab Georges. Okenn?

HON BERNARD GEORGES

Yes. Mon annan en propozisyon Mr Chair. E mon le zis pran sa ki Onorab Pillay in dir. Efektivman. Problem avèk *FAD* se ler zot ariv lo en lans, lo en zil. zot ariv lo en zil *on the windward side* akoz se la kot zot ganny anmennen e sa se landrwa pli difisil pour ou *access*. Akoz ou dan laroul, ou dan resif e ou pa kapab

anmenn en bato, pour *retrieve* li.

E sa i fer, i fer problemm vin doubleman difisil. *May I suggest*, en konpromi. Ki nou retir sa mo, “*stranded*” kot i été, e zis nou mete, “*the FAD is within coastal ecosystems, including stranded on beaches, reefs or in lagoons*”.

So sa i ava permet ler in ariv dan ou ekosistem *coastal*, ou kapab *deal* avèk li.

MR SPEAKER

Panel?

HON SEBASTIEN PILLAY

Nou problemm se ki nou napa en definisyon pour *coastal ecosystem*. E si nou napa sa, akoz nou pa konnen *coastal ecosystem*, si nou pe konsider, 1000,2000,3000.

So nou bezwen... Si nou kapab etabli, *what* ki nou *mean by coastal ecosystems then that's the best solution* ki nou kapab annan. *Otherwise without that, then* nou re-kree en lot problemm. Vwala kot nou ete.

MR SPEAKER

Ok, annou ekout *panel* ki zot lopinyon. Yes Minister.

PRINCIPAL MINISTER JEAN-FRANCOIS FERRARI

Kekfwa sa ki nou kapab fer se, pour nou pa pri lo sa size. Annou *move*, me selman nou

ava retourn lo la dan lazournen nou ava zwenn, nou ava kontinyen rod en solisyon.

E mon krwar nou kapab war en solisyon. I zis ki i pa devret *open ended* pour serten kategori dimoun.

MR SPEAKER

Ok. I annan en posibilite ki nou'n deza pran avan, ki nou *postpone* konsiderasyon sa. E dan *break, Bills Committee* avek *panel* i sey rod en *wording*. E a lafen *Bill* nou retourn lo bann ki nou'n sote, *ok?*

So let's move to the next one Onorab Hoareau e nou a – *yes* Onorab Georges, ou ti annan ankor enn?

HON BERNARD GEORGES

Wi, mon ti annan ankor de. *Happily*, zot pa pour kontroversyel. Lo sa prosen bout. *It is zis apre 2 (a) and (b) "it is not reasonably practical to obtain prior authorisation before taking action provided that the person shall notify the Authority in writing or by electronic means"* mon ti ava anvi, mon ti ava swete fer en modifikasyon la, se olye, *"the person shall notify"* ki nou met, *"the authority shall be notified"*.

Akoz *'the person'* annan de fwa i pour en senp travayer lo zil li. Mannyer i ete la, se si li i anmas sa *FAD*, fodre li ki

notifye. Tandis ki *'the authority shall be notified'*, i les li en pe pli larz.

I zis met en lobligasyon lo *notified* Lotorite, san met en problem lo sa travayer zil ki'n anmas sa *FAD* pour li, li menm li al anvoy en *email* kot Lotorite *SFA*. Mersi.

MR SPEAKER

Panel? Onorab Pillay, antretan, wi?

HON SEBASTIEN PILLAY

Mr Chairman. Largiman mon krwar la i se ki si par egzanp sa dimoun i en travayer *IDC*. E in ganny en direksyon *from management IDC*, pour al tir sa *FAD*, mon krwar sa ki problem ki vini se ki eski *the person would be IDC in this case* ki pe retir sa *FAD* ki pour enform zot.

Aprezan mannyer ou'n mete, ou'n met lobligasyon lo sa dimoun ki pe retir sa *FAD* li menm, sa *actual person* ki pe tous sa *FAD*. Se sa ki pe fer li enn pti pe konplike. Akoz i pe fer sa anba direktiv en lot dimoun.

So mon krwar i bezwen, lenportans se ki Lotorite i konnen. E ganny notifye ki sa *FAD* pe ganny tire. *Plus* mon krwar sa i rezondet sa lamannman ki pe vini.

MR SPEAKER

Panel, eski sa i akseptab? Yes, Minister ?

PRINCIPAL MINISTER JEAN-FRANCOIS FERRARI

PS i sizere ki nou get sa. Annou pran dernyen sa enn dernyen pti bout ankor.

MR SPEAKER

Nou postpone sa osi? Ok. Alright. Onorab Georges ti annan ankor enn.

HON BERNARD GEORGES

E finalman ankor mwen kontrovansyel son headnote. "Prohibition to tamper with or destroy", mon ti ava sizere ki nou servi. "Prohibition on tampering with or destroying property".

It's a prohibition on something rather than a prohibition to.

MR SPEAKER

Ok, sa mon krwar i straight forward. No objection. Mon pe remark enn pti keksoz ki mon pa ti'n – dan sa section 2 dan son trwazyenm laliny avan lafen.

"Of the retrieving party", napa en punctuation la. Apre i zis kontinyen avek nothing. Should it be a full stop and yes? Sorry, Onorab Georges?

HON BERNARD GEORGES

Sa full stop i la Mr Chair. I pa'n ganny delete at the end.

MR SPEAKER

Ok. So i la li. I egziste. Onorab Hoareau, nou annan 2 pwen la, ki nou'n note pour retourn lo la. More work for you. E nou a kontinyen.

HON JOHN HOAREAU

Wi, avek bann propozisyon mon'n note. Nou al aprezan, nou bezwen renumber the next section ki follow. Instead of 3 i vin 4.

Apre dan sa head note ki sivre "Use, possession, importation, purchase or sale of prohibited gear". So nou'n retir sa mo "and" after the word "purchase".

Nou al lo paz 44 aprezan. Subsection (5).

MR SPEAKER

Sorry. Eskiz mwan, mon pe get Lalwa an menm tan get lasal Onorab Esparon.

HON REGINA ESPARON

Mr Chair, mon zis annan enn pti - enn pti query lo sa zafer, "should advise the authority in writing within 72hours". E la mon pe mazin, aköz si mon pe get lozik.

En bato peser pe al lapes, i war en FAD pe drive, li normalman zot al 15 zour bann ki al zanmerant 15 zour- 8 zour. I pa pour trounen pour li vin notifie in writing.

Me selman taler Onorab Hoareau ti dir, servi mwayen kominikasyon ki petet i pa pour *in writing*.

MR SPEAKER

Me nou'n aksepte sa enn. Nou'n aksepte sa Onorab Esparon.

HON REGINA ESPARON

Ok.

MR SPEAKER

Ok. Yes, Onorab Hoareau, kot ou ti'n arive. Nou'n ariv lo paz 44. Subsection (5). Kot i dir, "Any person who contravenes subsection (1)" apre comma, "(2)" i ganny azoute "or (4)".

Nou al lo paz 46, section 28(1)(b) after the word, "behalf", "or" i ganny retire. Lo paz 47, 29(4)(a) after the word "ownership of a listed vessel", i ganny mete.

Paz 48 subsection (5) "(a)" dezyenm laliny, after the word, "the" nou pe met "ownership of the vessel" e nou pe retir dan trwazyenm laliny after the word changed "owner".

Nou al lo paz 49 - 30(4)(b). Dezyenm paragraf ki komans avek 'and to – annefe i sipoze kontinyen en sel paragraf (b). So i kontinyen sa bout "and to any other penalty provided under this Act" i ganny retire.

MR SPEAKER

Ok. Onorab Pillay?

HON SEBASTIEN PILLAY

Mersi Mr Chairman. Mr Chairman, *IUU* enn bann keksoz ki koman en Leta, en Leta parey nou menm en Leta Zil.

E ki annan en siperfisi lanmer ki nou bezwen *deal* avek seryezman. Nou pa an faver sa propozisyon ki en bato ki'n deza ganny, idantifye pe fer *IUU* e sanz *ownership* e sa *owner* i kapab kontinyen ek aktivite dan lapes.

I think there should be a deterrent, ki ganny fer so that, konmsi menm. Akoz par egzanp *let's say* mwan mon en *beneficial owner* en bato ki'n ganny war pe fer *IUU*.

So obviously mon ganny *fine* pour *IUU*. Be solman mon kapab *still* vann sa bato at a profit apre, e fini *recover what* mon'n perdi.

So the point i se ki *the deterrent should extend to* sa bato. Akoz ler ou pe dir la, ou pe dir si sa *new owner*, i kapab prouve ki sa mwan ki ti *beneficial owner in the first place*, mon nepli annan lyen ek sa bato, then i kapab pran sa bato e i retourn kot Lotorite e dir *ok* mon le al lapes.

Nou pe get seksyon 'a *listed Vessel*' in regards to 'a *listed Vessel*'. Akoz si nou pran - page 48 zis anba kot section (5).

I dir, “*A listed vessel shall not be —*

a) *approved for or granted registration*”, ok “*except if the ownership of the vessel has changed and the new owner has provided sufficient information demonstrating previous owner, operator*”, pa pe engage in IUU. Akoz basically nou pe koz lo en bato, ki'n deza fer en lofans. Konpran?

So konmsi i pa fer kler ki arive dan lenstans kot ou tyonbo en bato ki'n fer IUU. *Illegal fishing, right?*

Ou sezi en bato ki'n fer IUU. *If I may — si panel i kapab klarifye Mr Chairman. Mersi.*

MR SPEAKER

PS, pour adrese?

PS ROY CLARISSE

Mersi, Mr Chair. Mr Chair, dan sa lenstans anba (5) - seksyon (5), letan nou koz en *listed vessel*, i en bato ki ganny deklare par en RFMO konmkwa i en *IUU vessel*. I pa en bato ki Sesel atrape fer lapès ilegal.

Ki arive, dan bann *Regional Fisheries Management Organization*, i annan bann bato ki ganny dekouver pe fer bann lapès ilegal. Me selman zot pa zanmen ganny en konviksyon. So zot ganny liste koman bann bato ilegal.

E sa provizyon pe dir ou, si ou annan en bato ki'n ganny liste koman en bato ilegal. Ou pa kapab *licence* li. *Unless* sa bato, son *owner* i pa sa *owner* ki ti fer sa lapès ilegal ki'n fer li ganny liste, sa *owner* in sanze or sa dimoun ki pran sa responsabilite sa bato napa okenn benefis operasyonnel ouswa finansyel ek sa bato.

Savedir letan ou annan en bato ki'n ganny liste anba en *RFMO as an IUU vessel*, pour sa bato kapab reantre dan lapès fodre sa *previous owner* napa okenn lentere, *be it operational or financial* ladan.

MR SPEAKER

Yes, Onorab Pillay?

HON SEBASTIEN PILLAY

Mersi, Mr Chairman, byen vitman akoz i pour vin en pwennvi lopinyon. E mon pa pour kapab al dan sa deba la. Nou'n fini fer en deba lo *merits*.

Zis ki mon le alert *panel*, ler nou tyonbo en bato ki pe komet en lofans lo *high seas*. Par egzanp drog. Serten lazans, i detri sa bato. E menm *Coast Guard* i fer parey. *Now*, nou, nou pe dir ki en bato ki *RFMO in identify as an IUU vessel*, i sanz *ownership*, i posib pour li ganny *registration* ankor ek nou si mwan koman nouvo *owner* mon kapab prouve poudir, sa

previous owner ki'n ganny convicted or a fine fo IUU, i nepli annan lyen lo sa bato.

Mwan the point that I'm saying is sa bato li menm become forfeit by virtue of in fer RFMO. Me zot, zot pa kapab fer sa. So that just, matter of process.

MR SPEAKER

Mon konpran ou. PS, wi? Yes, PS?

PS ROY CLARISSE

Mr Chair, *if I may*. Akoz sa provizyon osi tou i *derived from* en IOTC Rezolisyon lo IUU. Akoz nou bezwen pran kont ki pa bato ki fer aksyon ilegal, se operater *or* dimoun.

MR SPEAKER

Wi, mon konpran ou pwen me selman, mon konpran osi lozik ki PS pe sizere. So nou a bezwen les li lanmen si ou'n aksepte. Onorab Hoareau, *back to you*.

HON JOHN HOAREAU

Mersi, Mr Chair. Mr Chair, nou'n ariv lo paz 49. Seksyon 30(4)(b). Mon'n dir apre sa *fine 3 million*, nou retir, *“and to any other penalty provided under this Act”*. Sa bout i ganny retire.

Lo paz 50, 31(2), nou komans avek, *“An operator”* dan plas, *“The operator”*.

32(3). Nou komans avek, *“An operator” instead of “where an”* i ganny retire.

MR SPEAKER

Onorab Hoareau. Kote ou ete?

HON JOHN HOAREAU

MR SPEAKER

Korek. So i vin 3 apre 3 i annan (a), (b) avek li.

HON JOHN HOAREAU

Wi, sa nouvo 3 i annan (a), (b). Sa 3 par lao li i ganny retire. I vin ansanm – sa paragraf i vin ansanm avek 2.

MR SPEAKER

Avek 2. Ok. I enn pti pe konplike. Onorab Hoareau mon sizere ki nou pran poz la. Ler ou ganny sans, regard sa *numbering*. E ler ou trounen nou a komans la *at this point*.

E ou a propoze lekel *numbering* ki. Nou a pran poz i en long *Bill*. Nou bezwen fer sa ki nesese, pour *deal* avek li.
